7. **OFFER VALIDITY PERIOD:** - Bid shall remain valid at least for a period 120 days after the date of opening bid prescribed by the purchaser. A bid valid for a shorter period may be rejected by the purchaser as non-responsive. In exceptional circumstances, the purchaser may solicit the bidder's consent to an extension of the period of validity. The request and the response there to shall be made in writing or by e-mail.
8. **COST OF THE COMPUTER/EQUIPMENTS/ITEMS MENTIONED ON WEBSITE:** - Please quote best minimum prices as far as practicable and applicable for a premiere Educational Institution. The cost of the equipment/items should be inclusive of all taxes and statutory levies. Labour installation charges, packing, insurance, freight, Pre installation requirements etc, should be mentioned separately (inclusive of all taxes **livable** on them).
